

## 2019 Bats for the Future Fund RFP Goals & Objectives

### **BFF Objectives**

- Advance field treatments and management tools to prevent exposure of bats to Pd and improve survival from WNS
- Implement field treatments, management tools, conservation strategies to help WNS-affected bat populations recover
- Support research leading to development *and* deployment of treatments and management tools to perpetuate viable populations of bats





## BFF Epidemiological Focus

• Leading Edge: where Pd has been detected and bats may be affected

✓ Field treatments to prevent spread and minimize impacts

- Established Area: where *Pd* and WNS have caused significant mortality and all hibernacula are assumed to be impacted
  - ✓ Protect potential survivors and recover remaining populations



Note: Map is illustrative, not definitive

## Program Priorities

- 1. Field treatments/management tools that prevent exposure of bats to *Pd* or improve survival from WNS
- 2. Field treatments/management tools/conservation strategies that help WNS-affected bat populations recover and rebound

### **Project Examples**

- Biological or chemical control agents
- Vaccines and other immune modulating techniques
- Genetic and genomic manipulations
- Habitat modification and enhancement strategies

- X Development of WNS detection methods or tools, UNLESS the development is directly related to deployment of a treatment method
- X Outreach and education programs
- X Political advocacy, lobbying, etc.
