### PROGRAM PRIORITIES:

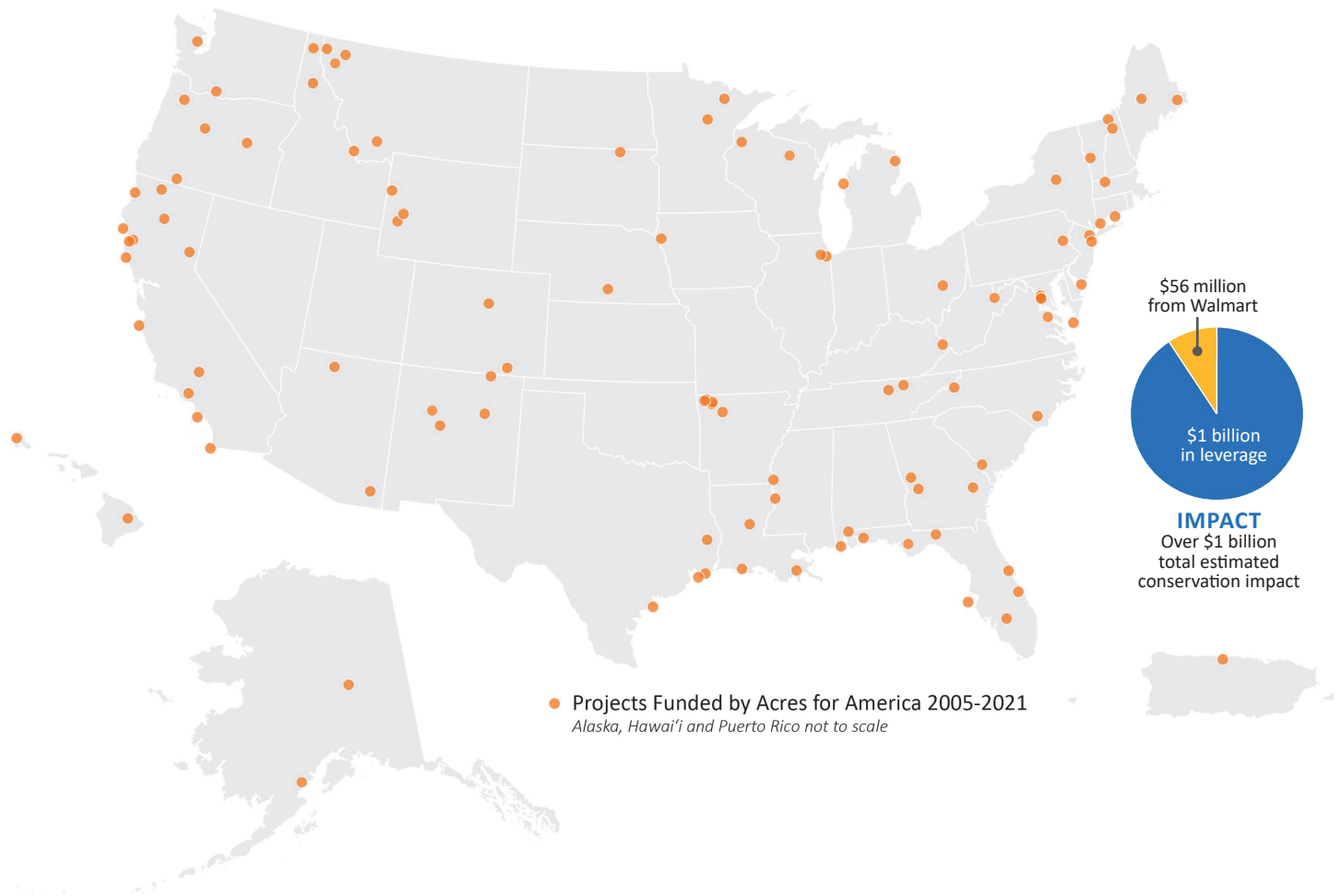
- Conserve critical habitats for birds, fish, plants and wildlife

## RESULTS TO DATE

Acres for America has far surpassed its original goal to permanently conserve one acre of wildlife habitat for every acre of land developed by Walmart Stores – approximately 100,000 acres as of 2005.

Since its inception, the Acres for America program has supported projects that have:

- Protected 1,859,700 acres – an area comparable in size to Everglades National Park
- Connected over 10 million acres of protected lands to support landscape-scale conservation and wildlife migration
- Funded 107 projects in 42 states, the District of Columbia and Puerto Rico
- Provided nearly \$4 million in emergency response funding to protect fish and wildlife that were immediately threatened by the Gulf of Mexico oil spill in 2010 and Hurricane Sandy in 2012
- Restored urban lands and habitats and connected youth to the outdoors by investing more than \$1.8 million in community-based projects located in New York, Chicago, Los Angeles, San Diego, Denver, Bridgeport, Portland (OR), Albuquerque and Washington, D.C.
