CBSF QUICK REFERENCE PROJECT GUIDE

BACKGROUND

This guide is intended to provide prospective Chesapeake Bay Stewardship Fund applicants with assistance in selecting the most appropriate grant program to apply for based on primary proposed activities.

While NFWF does not require consultation prior to application, we strongly encourage interested applicants to contact NFWF staff or its contracted field liaisons to discuss their proposed project, gather constructive feedback in developing a competitive proposal, and to obtain guidance on the most appropriate program and funding opportunity for project consideration.
