## BACKGROUND

The Cumberland Plateau Stewardship Fund (CPSF) was established in 2013 to restore forest and freshwater habitats to conditions that will improve associated wildlife species and the health of freshwater systems, while advancing strategies to support working forests and farms. CPSF helps nonprofits, government agencies, and other local partners work together to accelerate restoration of shortleaf pine and oak savannas, riparian forests, grasslands and in-stream habitats in strategic geographies within the greater Cumberland Plateau, one of the most biodiverse regions in the United States.

The CPSF awards competitive grants annually that support seven priority strategies: establishing shortleaf pine and oak forests; enhancing and maintaining existing shortleaf pine-oak ecosystems; reforesting previously mined lands; restoring and enhancing riparian forests and watershed health; increasing adoption of conservation practices on agricultural lands; expanding and coordinating technical assistance and outreach; and facilitating conservation easements. In 11 years, the fund has invested more than \$14.2 million across 74 projects, leveraging \$12.1 million in matching contributions to generate a total conservation impact of \$26.3 million

The CPSF is a public-private partnership, with federal funding provided by the USDA Natural Resources Conservation Service, U.S. Forest Service and the U.S. Fish and Wildlife Service, as well as private funding from International Paper's Forestland Stewards Partnership, Cargill, Nestlé USA and Altria Group.

## FACT SHEET

#### **GOALS AND OBJECTIVES**

The goals of the Cumberland Plateau Stewardship Fund are to:

- Restore and enhance shortleaf pine and oak savanna forests on public and private lands
- Restore and enhance riparian forests and freshwater habitat
- Increase populations of forest and grassland birds, as well as fish, amphibians and other aquatic species
- Engage private landowners through outreach, training and technical assistance activities that contribute to the restoration and enhancement of habitats and wildlife, and supports working forests and farms by demonstrating their environmental and socioeconomic benefits

The fund's investments are targeted primarily to focal areas that were selected by scientifically analyzing upland and riparian forest and freshwater systems within the greater Cumberland Plateau region. These focal areas represent locations with the greatest potential for forest and freshwater habitat restoration for terrestrial and aquatic species based on resource mapping, interviews with practitioners in the
